I/we agree that, if any of the information (cell numbers, contact detail, medical information) changes we will inform <b>Annie's Ark Preschool</b> immediately.	
I have read and agree to the full contents of the Parent Manual (in Addendum A below).	
I understand that disregarding these policies can result in termination from Annie's Ark Preschool.	
A non-refundable administration fee of <b>R500</b> will be paid upfront and will secure a place for my child at Annie's Ark.	
I agree that what is referred to as the monthly fee is an installment of the annual fee that I agree to pay and therefore the installment must be paid every month of the year.	
I agree to the monthly fee of <b>R2000</b> per month for January and February 2025. From 1 March 2025 fees will increase to <b>R2300</b> .	
If my child only starts on or after the 15 <sup>th</sup> of the month, then only half the fees will be required. This excludes January.	
I agree that the fee will be paid by the first day of each month or upfront before my child joins Annie's Ark Preschool. There will be a late fine of <b>R100</b> for every day payment is late.	
Aftercare fees are <b>R1000</b> for the month but own food to be provided. It's an additional <b>R300</b> per month if you would like us to provide lunch. An afternoon snack must be packed in.	
I agree to adhere to the opening hours of 6:30am - 6pm on Monday to Friday.	
I agree that collection of my child after 6pm will result in a late pick-up fee of <b>R75</b> per hour.

## Addendum A - Parent Manual

#### **Hours of Operation**



- Monday to Fridays: 6.30 am until 6.00 pm.
- Annie's Ark Preschool will be closed weekends and public holidays and specified school holidays.
- Annie's Ark Preschool operates during school holidays, but will be closed during the December school holidays.

## **Arrival and Departure Times**



- Children can be dropped off from 6.30 am.
- No breakfast served after 9.00 am
- Children of parents who are left at the Annie's Ark Preschool after 6pm will be required to pay a late fee
  of R75 per hour.
- Parent/guardian to sign in and out every day, leaving a contact number on the register.

## **Arrangements Regarding Fetching and Transport of The Child**



- On enrolment parents/ guardians are to notify the centre as to who will be responsible for collecting the child.
- Parents are to notify the Principal if another person will be collecting the child.
- Daily transport is not provided by Annie's Ark Preschool
- Should transport be offered as a service at the centre, it is offered independently of Annie's Ark Preschool

#### **Outings**



- Parents will be notified in writing (including permission slip) at least 3 weeks before an outing.
- Payment or arrangement for payment must be made 5 days before the outing.

#### **Fundraising**



• All parents are encouraged to help with fundraising efforts, financially and/or offering of their time.

#### **Admission of Special Needs Children**



• Children with disabilities are welcome to join Annie's Ark Preschool should the facilities be suitable.

- Should an individual carer be needed by the child, the parents will provide one at their own cost.
- Testing for HIV/AIDS for attendance at centres is prohibited and as such the Centre does need to know the HIV/AIDS status of children & their families.



## III or Injured Children



Children who show symptoms of being ill should be kept at home until they are well enough
to attend the centre, and there is no possibility of other children contracting the illness or
disease.

## Children who fall ill or are injured while in the care of Annie's Ark Preschool



- If a child is injured whilst in the centre, the seriousness of the injury is assessed immediately.
- If it is a minor injury, which can be treated by the staff, the child will be kept at the centre. The parents will be notified at the end of the day when the child is collected.
- In the case of a more serious injury the parents will be contacted immediately and expected
  to collect their child and seek medical assistance.
- In the case of an injury requiring immediate medical assistance, staff will call an ambulance.
- A parent must sign the incident report.

## **Monthly Fees**

- Daycare: Fees must be paid for 12 months of the year @R2000 per month for January and February 2025 and @R2300 per month from 1 March 2025 onwards.
- Siblings are offered a 5% discount.
- A toiletry and stationery list will be included and siblings share one list.
- Aftercare: Fees are R1000 for the month but own food to be provided. It's an additional R300 for lunch to be provided. An afternoon snack must be packed in.
- A non-refundable once-off admin fee of R500 will ensure your child's place.
- The due date for payment of fees is the 1st day of every month or upfront when your child begins. If your child begins at Annie's Ark from and after the 15<sup>th</sup> of a month then only half the fees need to be paid for that first month. There will be a late payment fine of R100 per day for everyday that payment is late.

- If paying cash, please ensure to get a receipt.
- If you are in arrears of two months and do not make an arrangement for payment with the Principal, you will be given written notice to make payment and / or find another centre for their child.
- The full amount of fees will be payable whether or not a full month of centre is attended.
- All fees owed to the Centre must be paid in full or legal action will be taken.
- Please give one month's written notice if your child will not be returning to the centre.

#### Clothing



- At least one clean change of clothing is to be sent in the bags every day.
- Clothing/possessions must be marked with permanent marker.

#### **Food**



- Breakfast and lunch will be provided as per centre policy.
- Parents to pack a morning snack (a sandwich, a yoghurt and one fruit).
- A waterbottle must be packed in.
- No sweets, chips or sweet biscuits please.
